#### A Cllr Jane Page

Longlands, the Lawn Cemetery and Jubilee Park have been inspected and are in good condition. Cllr Lewis noted that a number of yew trees have been cut down by the churchyard, and are available to residents to take away in return for a donation.

#### B Cllr Shovelton

Cllr Shovelton is currently engaging with local landowners whose property includes public footpaths. Researching costs of new signage.

Jubilee Park: the new play equipment has been satisfactorily installed in the park and is already a popular attraction. The final piece of outstanding work is for an enclosing fence that needs to be installed. This is longer than at first anticipated, and the cost will be higher. Councillors agreed to take three quotations before choosing a supplier.

ACTION Clerk to confirm specification with Cllr Shovelton and bring three quotations to the April meeting.

# 39/2019 Chair's Agenda Items

A Jubilee Park

Cllr Lewis met with residents last Sunday afternoon to discuss future improvements that might be considered in the park. Dog owners who attended felt that ultimately, they would prefer to see a separate space being made available to them where they could exercise their dogs, but welcomed the offer of a trial period in the park once the fence around the playground was installed. Councillors would agree a set of ground rules before the 12 month trial period commenced. There was a short discussion on what extra facilities might be purchased by the parish council for use in

the park.

ACTION Clerk to obtain costs of dog bin; signage; bench; path laying and report back at the April meeting. Chair would speak with Mr Crabb about cutting back the laurel bushes in the park.

Opening Day for the park's new equipment will be Saturday 20 April, and Cllr Phil Seeva will be invited to attend. A parish picnic will be planned so that residents are encouraged to bring parents and children together.
