Cllr Kevin Shovelton Chair. Cllrs: Jonathan Ellis; Lindsey Ellis; Mark Featherston; Roger Cook; Sarah Whiting; Patricia Hopwood. Also, present Parish Clerk John Hesketh and Cornwall Councillors Jane Pascoe and Armand Toms. There was 1 member of the public present.

036/2024 Chair's Welcome & Housekeeping

Cllr Shovelton welcomed councillors and explained that he had received a late planning application immediately prior to the meeting that he wished to discuss. He declared the matter as 'urgent' and will be determined under Item 41 below.

037/2024 Apologies

038/2024 Declarations of interest

No declarations of interest made, or dispensations requested

039/2024 Public Participation

A resident attended to raise concerns about road safety at the junction from Trewidland onto the B3252. They asked if new warning signage could be installed on the main road approaching the junction and a reflective mirror installed opposite the exit from Trewidland. Cllr Shovelton explained that the parish council shared his concerns and had had long discussions with Cornwall Council Highways about safety at this junction. New 'slow' signage had been painted on the road surface on either side of the junction, and additional warning signs erected in the approach. Vegetation adjacent to the junction had recently been cut back to allow a clearer view of traffic approaching from Bylane End.

Cornwall Cllr Armand Toms will be meeting with the new sector Inspector Martin Whitehouse to discuss this and other road safety matters in the near future.

Cornwall Councillors Jane Pascoe reported that: a white van that had been permanently parked by the approach road to St Keyne (close to Trussel Barn) had been reported to the police, and would be escalated if necessary; attended the recent defibrillator training in St Keyne; the Constitution and Governance Committee had reversed a previous decision that now permits parish councils to be examined at public planning sub-committee meetings; has been re-elected as Chair of the South East Cornwall Community Area Partnership with Cllr Hillary Franks as Vice Chair; encourages councillors to read the Tamar 2050 plan that is examining the future of travel across the Tamar River; continues to press for a review of the ban on household and DIY waste disposal at Connon Bridge HWRC.

Cllr Armand Toms endorsed residents' concerns about road safety at the Trewidland junction and will follow up with enquiries for the cost of illuminated warning signs; new repair work on the tunnel at Saltash that will include night-time closure will be taking place during the winter of 2024; notes that some households are still experiencing problems with waste recycling; remains concerned about the reduction in NHS dental practices across the county.
