082/2024 Public Participation

Cornwall Councillor Armand Toms reported that: he now chaired the Adult Social Care & Public Health single issue panel which had noted the underfunding of public health in Cornwall compared to the average for England; budget proposal for Cornwall for 2025/26 had been agreed with a 4.99% Council Tax increase, inclusive of a 2% adult social care precept (consultation begins 15 November 2024 until January 2025); continued road closures in Looe are causing problems for businesses in the area; is supporting a motion to stop changes proposed in the taxation of farms; noted that DEFRA is consulting on bathing water quality, closes 23 December 2024. Search online for 'Defra bathing water' to take part.

Cornwall Councillor Jane Pascoe reported that: attended the Remembrance Parade and church service in Liskeard and Dobwalls on 10 November; made a peaceful representation at the Tamar Tolls Public Enquiry on 15 October; concerned about the plans to close Liskeard Post Office, and has written a letter with Cllr Nick Craker to Post Office management asking for a meeting between them and local stakeholders; noted the inconvenience caused by building and improvement works at the Cattle Market in Liskeard and explained that it would include a new service hub, bus terminus and extension to Dean Street surgery. There would be no loss of car parking spaces once the building works are completed. All Cornwall Council car parks will have free parking on 7, 14 and 23 December.

F Government consultation on remote attendance and proxy voting

The chair supported a roundtable discussion of the consultation and everyone agreed that because of the complexity of the questions, it would be simpler if residents and councillors were encouraged to complete the survey themselves.

G Consultation of proposed 20mph areas in Trewidland

Councillors discussed the proposals and agreed that they would support the consultation by distributing flyers and engaging with residents. Suggested that the reduced speed limit should be extended past Trewidland school. The consultation will run from 27 November – 20 December 2024.

A Cllrs Blackwell & Woodman

Trewidland village hall reported that its recent quiz night had been well attended, and progress was being made on the installation of Wi-Fi.

St Keyne village hall reported that the site of the original village hall would be auctioned on 15 November and the new solar panels had been successfully installed.

B Cllrs Shovelton & Featherston

Reporting back on maintenance and repairs in Jubilee Park, including specification for fence and bench. Report postponed to January 2025.

C Cllrs Lindsey Ellis & Hopwood

Cllr Hopwood reported that: The first full year with four edition of the magazine had been published and welcomed by residents; the cost of printing the magazine had been covered by advertising sales so there was no cost to the resident taxpayer; the newsletter had proved to be a valuable and cost effective way of ensuring that events across the parish were publicised, and the parish council was able to promote its own work to every household. Cllr Blackwell thanked Cllrs Hopwood, Lindsey Ellis, Woodman and Shovelton for all their work this year in making it a success.
