## 104/2024 Public Participation

Cornwall Councillor Jane Pascoe reported that: she had attended a meeting with CC Highways and the parish council Chair to resolve an issue with road flooding at Penhale Lane that resulted in Highways accepting responsibility for clearing the drain, schedule of works to be agreed; attended the carol service at St Keyne Church; reported that the Liskeard Young Farmers Annual Tractor Run had raised over £2,500; Rosedean House Surgery will become part of OneMedicare healthcare provider from 1 February 2025 and will progress the expansion of the surgery space (with a public information session planned for Spring); government proposals to create a wider Mayoral authority (that would include Cornwall, Devon, Torbay and Plymouth) that would manage policing, transport and other strategic functions are due to be published shortly – Cllr Pascoe will update councillors and residents at the earliest opportunity.

# 108/2024 Councillors Reports

## A Cllrs Blackwell

Reported that in St Keyne: sale of the former village hall site had been delayed due to concerns about ownership; had attended the New Years Eve party; will make enquiries about the siting of the donated portrait of HM King Charles III.

### B Cllr Woodman

Reported that in Trewidland: had attended a Christmas Carol service at the hall; will consult with committee members about the offer of a portrait of HM King Charles III.

## B Cllr Featherston

Reported that the current damaged bench in Jubilee Park could not be repaired. It was **Resolved to purchase** a replacement bench made of recycled materials. Proposed Cllr Featherston. Seconded Cllr Blackwell. All agreed.

Action: Clerk to issue purchase order and arrange delivery.

#### C Cllr Cluer

The Green Team meeting held on 18 November 2024 reported that: it had discussed priorities for the coming year; ways in which the villages could be energy independent; would link its work to the Looe Valley Festival; consider including projects for the Liskeard Foodbank with localised planting in Jubilee Park and other areas; promote and encourage footpath use.

## D Cllr Whiting

Reported that her meeting with Cornwall Council to discuss progress on improving road safety on the B3252 was: new signage along the road would caution bikers (not car drivers) about excessive speed; periodic monitoring of speeding vehicles was being carried out; discussions with the farm owner opposite Fursdon to alter its entrance were proceeding; CC were negotiating with a home owner with a property at the junction of Bylane End and the B3252 to improve visibility for drivers approaching the junction.

## E Cllr Hopwood

Asked if councillors could send her an informal photograph of themselves and sort pen-portrait for publication in The Informer.

# 109/2024 Clerk's Report

A Portrait of HMK Charles III for Trewidland Village Hall

Clerk presented examples of portraits of the new king that might be appropriate for the hall. It was **Resolved to agree to fund** a purchase of up to £100 for the village hall. Proposed Cllr Lindsey Ellis. Seconded Cllr Woodman. All agreed.

Action: Cllr Woodman to get agreement from Trewidland Village Hall on the final choice of portrait design, frame and size. Clerk to order and arrange delivery.

## B Election Countdown 2025

Clerk reminded councillors that local elections are scheduled to take place on 1 May 2025, and although county elections may be postponed (see Item 104 above) parish council elections are expected to continue. The deadline for nominations will be 2 April 2025. Clerk is attending two election briefings on 14 & 18 January 2025, and will report back with a timetable for preparations, nominations and administration.
