## 115/2024 Public Participation

A resident from the Footpath Working Group attended to ask about the future access that members of the public would have to the footpath that crosses the railway line between St Keyne and Little Windsor (and emerges in the lane between Trewidland and the B3254). Chair has previously written to the landowner and is still waiting for a response. Resident reported that their public request for historic evidence of its use had been received and may be helpful in determining the outcome. Chair suggested that the group meet again prior to the next public meeting to consolidate its arguments.

Cornwall Councillor Jane Pascoe reported that: the situation with drain clearing at Penhale Lane will be resolved as soon as the legal papers have been cleared; the Peninsula Transport Consultation is now current until 3 March 2025 (see link below); Cornwall Councillors recently considered government proposals to allow greater autonomy and devolution for Cornwall, but voted against any cross-border combined authority deals, calling for a more meaningful devolution settlement that properly reflects the county's national identity and minority status (this decision does not affect county and parish elections scheduled for 1 May); the recent fire at Mount Edgcumbe is being investigated with a pledge to rebuild the damaged properties; Liskeard Town Council is holding a Visioning Workshop on 17 February at 5.30pm in the public hall where residents are invited to participate in developing an action plan to improve the town.

#### 119/2024 Chair's Report

A Looe Valley Festival April 2025

This council's contribution will be the public showing of a film 'Six Inches of Soil' at St Keyne Village Hall on 11 April 2025. This film is about a group of British farmers and their challenge to the current system of food farming. As part of the exhibition, an expert panel will be attending to take questions from the audience.

B Strengthening the standards and conduct framework for local authorities in England Clerk presented a summary of this national consultation, and Cllrs Shovelton, Hopwood and Featherston volunteered to complete the survey. Chair encouraged remaining councillors to participate.

The Chair reported that the AGM of St Keyne Village Hall would be held on Sunday 16 February when new committee members would be elected. Cllr Jane Pascoe has agreed to Chair this meeting to oversee the elections.

Cllr Woodman reported that use of Trewidland Village Hall continues to progress with more popular indoor events, including table tennis and quiz nights. She agreed to purchase a portrait of HMK Charles III on behalf of the parish council for donation to the hall.

Action: Clerk to liaise with Cllr Woodman to reimburse her expenses.

Reported that the replacement bench in Jubilee Park had been ordered and was scheduled for delivery on 7 March. He will link up with Cllr Shovelton to assemble and install the new bench, and arrange disposal of the old one.

The latest edition of The Informer newsletter had been published and distributed. The Chair thanked Cllrs Ellis and Hopwood for their continuing work to edit the magazine, whilst also attracting new advertisers and remaining financially sustainable.
