15/2018 Public Participation / Cornwall Council report, if available.

Mrs Patricia Hopwood, Treasurer for the St Keyne Village Hall, presented a financial summary for the hall and explained what their future plans were for improving income and extending the facilities available to residents. Cllr Boney congratulated the management committee on its achievement in turning its finances around and for accumulating proper reserves. Mrs Hopwood thanked the parish council for its donation (Item 22A below). Mr Chris Fitzpatrick asked if it might be possible to upgrade the broadband package that the parish council had agreed to fund for two years.

ACTION Clerk to speak with Plusnet and investigate alternative packages.

Report from Cllr Phil Seeva

The councillors Community Chest fund had awarded the St Keyne Garden Club the sum of £200 as a contribution towards its planting for Jubilee Park. This fund is now closed until 1April 2018, and residents are encouraged to make applications if they have community projects which need supporting. The next full Cornwall Council meeting in April will be making a decision on funding a stadium for Cornwall. Central government will be making a contribution, and Cornwall Council be asked to add £2-3m.

Item 19	Grounds maintenance at Sandy Close The Chair reported that the overgrowth of weeds on the pathway owned by South West Water had been badly cut but the debris had not been cleared. ACTION Clerk to contact SWW and escalate our complaint. Ownership of the small area on Sandy Close has been identified, and councillors noted that rat poison had been introduced to the area. ACTION Clir Seeva will approach the land owners and ask about ground clearance.
Item 66C	Lawn Cemetery briefing The Clerk had recently attended a course on cemetery legal compliance and reported that the basic requirements of lawn cemetery were in place: a complete burial register, ground plan and paper trails for every plot. The forward plan for 2018/19 included a review of cemetery regulations and operations, including new directional signage. Clerk to progress the agreed plan.
Item 9C	Options for deposit accounts and surplus funding Clerk reported that Cornwall Council offer a deposit scheme where parish councils can deposit their surplus funds. The current rate of interest is significantly higher than that offered by the Barclays Business Saver account.
